**For the purposes of this Annex, the following terminology is used<sup>1</sup>**

NON-RINSING PRODUCT	a cosmetic product intended for long-term contact with the skin, hair or mucous membranes
RINSE-OFF PRODUCT	a cosmetic product which is intended to be removed when applied to the skin, hair or mucosa
HAIR PRODUCT	a cosmetic product intended to be applied to the hair or facial hair, except for the eyelashes
SKIN PRODUCT	a cosmetic product intended to be applied to the skin
LIP PRODUCT	a cosmetic product intended for use on lips
FACE PRODUCT	a cosmetic product intended for use on the skin of the face
NAIL PRODUCT	a cosmetic product intended for use on nails
ORAL PRODUCT	a cosmetic product intended to be applied to the teeth or oral mucosa
PRODUCT FOR APPLICATION ON MUCTION MEMBRANES	the product is intended for use on the oral mucosa, rims (edges) of the eyes, external genitalia
EYE PRODUCT	a cosmetic product intended for use around the eyes
PROFESIONAL USE	the use of cosmetic products as part of professional activities
